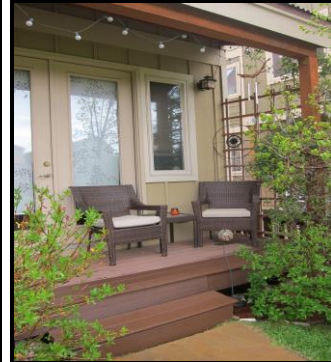

I/We further acknowledge restrictions regarding use and occupancy, including but not limited to a requirement that this home must be occupied by the owner(s) of the home as their sole place of residence at least six (6) months per year, commencing upon ownership of the property.

I/We acknowledge that if I/we must leave the area for a limited period of time, and desire to rent the Unit during such absence, a leave of absence may be granted by the Town of Carbondale or its assigns for up to one (1) year upon clear and convincing evidence demonstrating a bona fide reason for leaving and a commitment to return to live in the unit. A letter must be sent to the Town of Carbondale at least thirty (30) days prior to leaving, requesting permission to rent the Unit during the leave of absence. Notice of such intent, and the ability to comment, shall be provided to the Keator Grove Homeowners Association at the time of request to the Town of Carbondale, 511 Colorado Avenue, Carbondale, CO 81623. The leave of absence shall be for up to one (1) year and may, at the discretion of the Town of Carbondale, be extended for an additional one (1) year; but in no event shall the leave exceed two (2) years.

In executing this Acknowledgement, I/we hereby accept that this restriction which is intended to preserve and protect the value of properties within this neighborhood, and that both the Keator Grove Homeowners Association and the Town of Carbondale are authorized to enforce this requirement.
