It is your responsibility to make sure we have received your application. If another organization is mailing or faxing your application, you are responsible for making sure GCHA receives it. Upon receipt of your application, GCHA will send you a confirmation letter. If you do not receive a confirmation letter within 45 days after applying, please contact our office. We are not responsible for application that we do not receive. If you are interested in other Housing Programs through the Garfield County Housing Authority, please contact us at (970) 625-3589.

In October the Garfield County Housing Authority will conduct a lottery to determine who will be offered one of the 8 units. If you are one of the lucky winners, you will be contacted and asked to pick up a pre-qualification packet, so we can determine your eligibility. Applicants must be approved by the Garfield County Housing Authority and Lakota Ridge.

We plan to conduct a briefing during the 2nd week of November at our office in Rifle. You will be notified of the briefing date once it has been scheduled. Please be prepared to attend as it is a mandatory requirement.

Prior to the briefing we will ask for the following information:

- 1. Proof of ANY source of income such as: paycheck stubs, Social Security letters, unemployment, OAP, veteran's benefits
- 2. Verification of legal identity such as: copy of valid driver's license, birth certificate, passport- all members of household
- 3. Copy of Social Security Cards- all members of household
- 4. Copy of any assets- latest bank statements for checking and savings, stocks, bonds, CD's etc.
- 5. Latest tax return (only if self-employed)
- 6. Verification of medical expenses
- 7. Proof of legal residency or employment in Garfield County.
