

### **Notes for Other Housing Authority Jurisdictions:**

The Garfield County Housing Authority is currently **absorbing** incoming ports.

HUD regulation 24 CFR 982.355(c) (4) **requires** the initial PHA to provide the receiving PHA with the most recent form HUD-50058 and related verification information. Related verification information **includes the family's Income Report from the Enterprise Income Verification (EIV) System.**

### **Notes for participants:**

If you are currently a Voucher participant in another Housing Authority's jurisdiction, you may be eligible to transfer to Garfield County. You may advise your current Housing Authority that we are currently absorbing incoming portability transfers. Your current agency must send Portability form HUD-52665 and other household documents to our agency before we will schedule a briefing with you. Please refer to our Payment Standards as Housing Authorities often have different income limits, payment standards and subsidy standards (the number of bedrooms you qualify for).

**If you are requesting portability, your initial Housing Authority must send your information to this agency. Once your file is received, a letter will be sent to the portability family inviting them to the next scheduled briefing. If you have moved from your previously assisted unit, please contact Garfield County Housing Authority with a current mailing address so that the process will not be delayed.**

**Please do not lease a rental unit before you meet with your Garfield County Housing Specialist. Do not move in before the unit passes a Housing Quality Standard (HQS) inspection. The maximum rent allowance for the Garfield County Housing Authority may be higher or lower than your current/recent unit.**
